Attachment A- Foreign Legal Consultant Declaration

- a. I am admitted to practice and am in good standing as a counselor at law or the equivalent in the foreign country(ies) for which I am registered.

- e. I agree to be subject to the jurisdiction of the courts of California with respect to the laws of the State of California governing the conduct of attorneys, to the same extent as a member of the State Bar of California.
- f. I agree to become familiar with and comply with the standards of professional conduct required of members of the State Bar of California.
- g. I agree to be subject to the disciplinary jurisdiction of the State Bar of California.
